The undersigned is pleased to issue notice for Public Auction of Six (06) nos. of Cows at CIH, Medziphema with the following terms and conditions.

#### Terms and Conditions:

1. The details of the cows for auction are as under:

1.	Cows (local breed)	06	160/kg

2. The public auction will be held at CIH, Medziphema on 18.10.22 (Tuesday) from 11.00 am onwards.
3. The base price mentioned in the list is the minimum reserved price at which the bidding will begin and quotes below the minimum reserved price will be rejected.
4. Acceptance or rejection of bids would be announced immediately as per bidding procedure.
5. The bidders should properly inspect the animal before bidding and no complaints will be entertained once the bidding formalities are done.
6. The highest bidder will have to deposit the whole amount on the same day.
7. The animal(s) would be handed only after receipt of full payment by the Institute.
8. The animal once accepted for sale will not be taken back or exchanged.
9. Transportation/delivery of animal(s) will not be done by the Institute. The purchaser will have to collect the animal(s) from the farm on the same day of bidding. In case he/she fails to do so, management and feeding cost of Rs.150/day will be charged. The institute will not be held responsible for any

- illness or death of the animal(s) after deposit of bid value by the successful bidder.
10. In no case will the auctioned animal be allowed to be kept in the farm for more than 7 days. Failing which, the Institute will be free to dispose off the animal suitably.
  11. Successful bidders should take precautionary measures while lifting/transporting the animal(s) from the farm. The Institute will not be held responsible for any injury to men or animal(s) during lifting/transporting.
  12. The live weight of the animals would be taken on the day of bidding.
  13. The Director, CIH reserves the right to accept or reject any or all of the bids/proposals or cancel the entire bidding process without assigning any reason.
